Marc has communicated with the other three districts and they are generally in agreement with requesting that players who appear to be concussed be removed from the pitch for the remainder of the game; they should then get a doctor's note when they are able to return to play. Dan Getz on behalf of the clubs stated that it would be very helpful for the clubs to receive guidelines on concussion from an umbrella organization such as VYSA or BCSA, including the circumstances when a player is to be allowed to return to the field of play, who is to decide whether there is a possible concussion and the management of a player's return to subsequent games. Jackie will contact BCSA to see what guidelines they have. FS will ask at the upcoming Youth Forum.

Peter Delaney wants a response on rubber pellets on turf fields – Floyd to confirm with Parks Board.
