1. Chairs Report

BCCSL has a board meeting on tomorrow night that Gregor will attend. Pre-season issues related to Stack, mainly that Stack is not allowing club names beside team names. Schedule was slightly late coming out, 6 games have been posted, up until mid-October. Club Presidents should be invited to our Board Meeting Oct. 7<sup>th</sup>, Jan. 6<sup>th</sup> and/or Feb. 3<sup>rd</sup>, 2020. AGM has to occur by May 31<sup>st</sup> every year. May 29<sup>th</sup> is proposed AGM date. Gregor will resend the Board meeting schedule.

## 2. Treasurer & RIC Report

All the invoices have been paid. Next up are Fields and Registration. Fields are all paid for. Invoices have to get out to the clubs by the end of this month.

Ewan - Fall registrations revenues for the last three years to track trends. Proposed sharing information across clubs to promote the game and improve the participation rates of the sport. David – if we are running a deficit again this year, we need to raise fees. Need to know if our registration numbers are going down again because it will affect our budget. Discuss raising fees in Nov meeting. Van U and VFC Metro teams will get invoices for refs. Outstanding - Sandra's outstanding July payment, Michelle's August invoice.

Travel subsidies from VYSA, BC Soccer also offers subsidies. Discussion ensued.

Sev – All Directors of VYSA are automatically members of VFC so all are welcome to attend. Sev will be sending out an invite, recruiting Board members. 2 VYSA reps, 2 Club reps, 6 elected members, 1 volunteer member for a total of 11 directors.

Gregor nominated David to be the VYSA rep at the VFC AGM Meeting. Motion was passed unanimously. Sev abstained. David was tasked to work with <mark>Smthe Smythe</mark> on the Letter of Engagement (Notice to Reader) or Audit. Smthe Smythe does the books for Killarney and the VYSA District.

### Referee Report – given by David

New assignment software Assignor.com is going very well. Van FC ran a mentorship game. First weekend of games are in progress of being assigned. Lost some old referees, getting some new ones. Previous schedule had favorites, so Bradley is trying to develop a broader group of referees. District refs get involved U13 – U18. Bradley is planning to employ crews of refs now. New laws of the game for this season – rules have changed. Clubs are responsible for making sure their coaches/players are aware of these new rules. Van U is running ref support meetings this week that Kevin O' Malley is running.
