### **Chair report - Sev**

- Sev provided written report supported by copy of BCCSL board meeting minutes from Feb 9/21 & Jan 12/21.
- Discussion around ongoing issues regarding Vancouver FC & Fusion FC amalgamation & dispute with VYSA. Agreed to defer this discussion to Committee #1 report (below).
- VYSA's BCCSL Technical Advisory Group Representative 2021/2022 season
  - For VYSA, given membership and uniqueness, this position should be for a one (1) year term. Calls went out to member clubs on March 2, and on March 7, using sophisticated selection criteria, Gus Karvelis, TD from Vancouver United, was selected.
- There was extensive discussion around U11 & U12 expansion within BCSPL
  - Canada and BC Soccer in consultation with BCSPL is expanding age groups to include U11 and U12 age groups; this is being pushed by Canada Soccer starting in 2021. With lower registrations, the realignment of Divisions and the phasing out of Metro, BCCSL Districts are concerned with the further reduction of competitiveness at U11, U12 & U13 going forward.
  - The VYSA generally opposed this initiative
  - Darren put forward the following Motion:
    - "If the new BCSPL U11 & U12 League is started in 2021, that it be inclusive of all affiliated clubs and not exclusive to BCSPL clubs."
    - Seconded by John
    - Carried unanimously
  - Board agreed that Sev would raise this issue at BCCSL meeting March 9/21.

### Secretary-Treasurer Report - David

- Presented February financial statements
- Fields still need to invoice clubs roughly \$39,515.44
- Still need to issue Field refunds of \$12,954.31 to the clubs
- Stale dated cheques credited back to income statement
- Projected budget surplus for fiscal 2020-21
- Will provide preliminary VYSA Budget for fiscal 2021-21
- Ewen requested a 5-year VYSA Budget plan
- Darren requested that Field refunds be issued to clubs asap
- VYSA Board needs to set future affiliation fees & other administration fees
- VYSA Board needs to decide whether to distribute BC Soccer Covid relief subsidy to clubs
- Ewen suggested further discussion about financials & budget ahead of VYSA AGM in June.
